# Non-randomised studies for the surveillance of covid-19 vaccines

Based on available Danish registers including the electronic immunization register, the Danish Vaccination Register and Danish Microbiology Database the surveillance of covid-19 vaccines will include vaccine effectiveness (VE) studies by cohort, studies by vaccine type and by prioritized target groups including residents in long term care facilities and healthcare workers as well as in the whole population. VE will be assessed for the outcome infection, as well as hospitalization and death.
